<p align="center">Proposal 18-1</p> <p>A proposed initiated law to authorize and legalize possession, use and cultivation of marijuana products by individuals who are at least 21 years of age and older, and commercial sales of marijuana through state-licensed retailers</p> <p>This proposal would:</p> <ul style="list-style-type: none"> • Allow individuals 21 and older to purchase, possess and use marijuana and marijuana-infused edibles, and grow up to 12 marijuana plants for personal consumption. • Impose a 10-ounce limit for marijuana kept at residences and require amounts over 2.5 ounces be secured in locked containers. • Create a state licensing system for marijuana businesses and allow municipalities to ban or restrict them. • Permit retail sales of marijuana and edibles subject to a 10% tax, dedicated to implementation costs, clinical trials, schools, roads, and municipalities where marijuana businesses are located. • Change several current violations from crimes to civil infractions. <p>Should this proposal be adopted?</p> <p align="right">Yes <input type="radio"/></p> <p align="right">No <input type="radio"/></p>	<p>Shall Kent County levy .25 of one mill which is equal to 25 cents per \$1,000 of the taxable value on all real and personal property subject to taxation for the period 2018 through 2024 inclusive for the purpose of providing planning, evaluating, and providing early childhood development services to persons up to age 5 and their parents? The amount raised by the levy in the first calendar year is estimated at \$5,702,887.</p> <p>In Kent County there are local authorities that capture and use, for authorized purposes, tax increment revenues from property taxes levied by the County. Such capture would include a portion of the millage levy. The total amount of captured tax increment revenue from such millage in the first calendar year of the levy is an estimated \$243,962. <p align="center">Proposal 18-2</p> <p>A proposed constitutional amendment to establish a commission of citizens with exclusive authority to adopt district boundaries for the Michigan Senate, Michigan House of Representatives and U.S. Congress, every 10 years</p> <p>This proposed constitutional amendment would:</p> <ul style="list-style-type: none"> • Create a commission of 13 registered voters randomly selected by the Secretary of State: • 4 each who self-identify as affiliated with the 2 major political parties; and • 5 who self-identify as unaffiliated with major political parties. • Prohibit partisan officeholders and candidates, their employees, certain relatives, and lobbyists from serving as commissioners. • Establish new redistricting criteria including geographically compact and contiguous districts of equal population, reflecting Michigan's diverse population and communities of interest. <p align="center">Proposal 18-3</p> <p>A proposal to authorize automatic and Election Day voter registration, no-reason absentee voting, and straight ticket voting; and add current legal requirements for military and overseas voting and post-election audits to the Michigan Constitution</p> <p>This proposed constitutional amendment would allow a United States citizen who is qualified to vote in Michigan to:</p> <ul style="list-style-type: none"> • Become automatically registered to vote when applying for, updating or renewing a driver's license or state-issued personal identification card, unless the person declines. • Simultaneously register to vote with proof of residency and obtain a ballot during the 2-week period prior to an election, up to and including Election Day. • Obtain an absent voter ballot without providing a reason. • Cast a straight-ticket vote for all candidates of a particular political party when voting in a partisan general election. <p>Should this proposal be adopted?</p> <p align="right">Yes <input type="radio"/></p> <p align="right">No <input type="radio"/></p>
